### Data processing on this internet site

- Browser type/ -version
- used operating system
- Referrer URL (the side visited before)
- Hostname of the accessing computer (IP address)
- Time of the server inquiry

These data cannot be assigned by 4reg.net certain persons. The data will be deleted after a statistic evaluation.

### Cookies

---

4reg.net is using so mentioned Cookies on several sites of this side. They serve for it, to make our offer more user-friendly, more effective and safer. Cookies are small text files, which are put down on your computer and which stores your Browser. Most the Cookies used by us are "session Cookies". They are deleted automatically after end of your session. Cookies cause no damage on your computer and contain no viruses.
